# **Declarations of Interest**

# Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensations, withdraw from the meeting.

# Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

# Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

#### Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer, etc would both probably constitute either an OSI or in some cases a DPI.

# **Background**

Part of the Environment Committee's remit is to work to eliminate plastic pollution in Deal. We have discussed providing support for 'Trash Free Trails' initiatives on the DTC website, and the possibility of organising litter picks, perhaps by ward, when the COVID 19 situation allows. Keep Britain Tidy's 'Great British Spring Clean' was also suggested to the committee by an interested member of the public.

Some desk research indicates that Trash Free Trails has not published any date in respect of their annual Spring TRT initiative, and their Autumn initiative was cancelled. The Keep Britain Tidy Great British Spring Clean has been postponed to September 2021 because of COVID 19.

The national lockdown makes organised litter picks impossible. Resources for Community Clean Up's are available for groups of up to six people from the District Council when such things become possible.

Dover District Council Issue 1 – Ecological Regeneration of Victoria Park

As DDC's Climate Officer has been unable to attend the Environment Committee a number of issues that could have been raised are now articulated as Memos to the Committee.

The first issue is the potential for DDC to ecologically regenerate Victoria Park.

Victoria Park is a green desert, a wasted natural space. Lots of cut grass. Not many natural features that could further assist biodiversity and ecological regeneration.

The map below illustrates some potential natural improvements including replacing the ugly chain link fence along Mill Road with a hedgerow.

- Contact Dover District Council and request they develop a detailed ecological regeneration plan for Victoria Park along the lines decided by the Environment Committee and implement it during 2021.

Dover District Council Issue 2 - Golf Courses as Carbon Sinks

As DDC's Climate Officer has been unable to attend the Environment Committee, a number of issues that could have been raised are now articulated as Memos to the Committee.

One of these issues is, could the golf courses across the district become carbon sinks?

Sports facilities like golf courses have been shown to have a positive impact on local biodiversity, quality of life and the economy. The grass of a golf course will sequester carbon through photosynthesis, but there are numerous emission sources associated with the management of golf courses which release CO<sub>2</sub> into the atmosphere. These include the engines used to power mechanised operations such as mowing and spraying, the application of agrochemicals, including fertilisers, and the disposal of waste.

A significant area of the district is dedicated to golf. There are four golf clubs:

- · Walmer & Kingsdown
- Royal Cinque Ports
- Royal St George's
- Prince's

The 149<sup>th</sup> Open is still scheduled to take place this year at Royal St Georges, the District is still engaging with the golf community including these clubs and the R&A.

Whilst the event itself will bring many positive things to the district and some environmental unsavoury things such as increased traffic and emissions, this engagement is an opportunity to discuss and actively encourage all the golf clubs to become carbon sinks by:

- Applying organic management techniques
- Proactively helping wildlife through natural landscape management
- Better water management
- Using electric powered work vehicles and rechargeable tools
- Employing renewable energy such as
  - Ground source heat pumps
  - Wind turbines
  - o Photovoltaic and thermal solar
- Promote environmentally sustainable behaviour amongst members

Dover District Council Issue 3 - Power Parks

As DDC's Climate Officer has been unable to attend the Environment Committee, a number of issues that could have been raised are now articulated as Memos to the Committee.

One of these issues is, will the District use their parks and in particular Victoria Park, North Deal Recreation Ground and Cowdrey Park to generate heat energy?



A new report from Possible, a UK Climate Action charity, has made the link between ground source heat pumps and parks.

Heat pumps are a well-developed solution to heating our buildings and a key low-carbon way (as long as they don't use standard HFC refrigerants) to moving away from burning gas. A heat pump collects the ambient heat around us, in the air, in water and in the ground, then concentrates it and pumps it into our buildings.

Possible's report shows how putting heat pumps beneath parks and playing fields, capturing a large area of ambient heat, could supply clean heat to leisure centres, community buildings, sports facilities, schools and homes, saving 8 million tonnes of carbon emissions each year, tackling climate change, improving air quality and generating an income for councils.

Subject: Library of Things – SHARE:UK

A Library of Things is a place where people can borrow the things they need rather than buy them. The focus is on things you might use occasionally such as tools, event items or camping equipment.

The Climate Assembly report recommended people share and repair more instead of owning all their things. This not only reduces the burden of ownership but offers environmental and financial benefits.

To put this in perspective, in 2019/20 SHARE:Frome not only saved it's borrowers £144,956, but calculated that it avoided:

- 199 tonnes in greenhouse gas emissions
- 254 tonnes of raw material use
- 22 tonnes of manufacturing waste

There are about a dozen Libraries of Things (LoTs) in the UK at the moment and SHARE:Frome (which was set up in partnership with Frome Town Council) are launching SHARE:UK this year with the aim to help facilitate the birth and growth of new LoTs. Member LoTs will be able to access funding pots acquired by the national body as well as being given templated systems, operational guides and start-up consultation.
