## **Disclosable Pecuniary Interest (DPI)**

Where a Member has a new or registered DPI in a matter under consideration they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensations, withdraw from the meeting.

## **Other Significant Interest (OSI)**

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

## Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

## Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer, etc would both probably constitute either an OSI or in some cases a DPI.

Subject: Southern Water

#### Information to note

At the Full Council meeting on 30 November the councillors discussed the Flood Action Task Force for Deal which had been set up by Natalie Elphicke MP.

As part of the discussion, they also considered that Parliament was debating the Environment Bill with changes aimed to the law to reduce sewage entering the rivers and seas from storm overflows by placing new legalities on water companies to take water pollution.

Members RESOLVED: That Cllr Mike Eddy will be the Deal Town Council representative on the Deal Task Force. To contact Natalie Elphicke MP to advise that Deal Town Council condemns in the strongest possible terms the decision by the MP for Dover and Deal to vote in favour of allowing water companies to continue to discharge raw sewage into the sea and water courses at levels above EU regulation standard. Given that the constituency is predominantly made up of seaside towns that rely on tourism and clean and safe beaches, her decision is perverse in the extreme. We urge Natalie Elphicke MP to represent the people of Deal by voting against these measures when the issue returns to the House of Commons for a second vote on 27th October.

An update on this will be reported at the next Full Council meeting and council will decide if they want to take any further action.

There will also be a full report included in the Environment Committee agenda for the February meeting which will include options for this committee to consider in assisting the safeguarding of the sea and water courses in Deal.

Subject: Planting Project 2021 - 2023

At the Full Council meeting on November 2021 Councillors resolved: "That Annual Planting is moved from F&GP to the Environment Committee"

At present there are:

- 10 wooden planters along the North Promenade
- 8 brick planters in the High Street
- 5 metal planters in South Street
- 2 wooden planters in Mill Hill
- 2 wooden planters in Alfred Square

There is also funding ring fenced to create more planting in Mill Hill.

In recent times, Councillors have been more prescriptive on the plants to be used. The planting today does not reflect well on the Council nor the Town. The Town Clerk, R.F.O and I are keen to take this project on and will of course take advice from qualified horticulturists.

The Planting Project will work with a local contractor to create planting that will brighten up our town all year round, for residents and visitors. The planting will adapt to the different microclimates of the different locations, but will include:

- evergreen planting
- phyto-sensor air pollution capture
- spring bulbs
- summer colour

The planting will have an emphasis on native plants and be environmentally sensitive.

There are also 70 hanging baskets that will be reviewed once the work on the planters and the Mill Hill planting has been completed.

The budget for the Planting Project is allocated annually by the Finance & General Purposes Committee. For 2021/22 the budget was £8,000 plus £4,000 for new planting in Mill Hill. At this stage, it is not envisaged that this budget will need increasing in 2022/23. The Planting Project should be able to achieve its objective of brightening up the town all year round, on the same level of funding.

#### Recommendation

- Members to agree that the Project Officer, R.F.O and Town Clerk complete this project.
- Members to agree to delegate decisions for this project, provided that it remains in budget, to the Project Officer, R.F.O and Town Clerk.
