#### Attachment 1

#### Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensations, withdraw from the meeting.

#### **Other Significant Interest (OSI)**

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

#### Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

#### Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer, etc would both probably constitute either an OSI or in some cases a DPI.

At the August Environment Committee meeting, Cllr Findley produced a report to propose a Declaration of Ecological Emergency **(see report below)**.

Following a lengthy discussion, Members RESOLVED:

1) The Environment Committee resolves to propose a Declaration of an Ecological Emergency to Full Council and refer this resolution and its implementation of actions on local nature protection and recovery to the Environment Committee, to include community engagement partnership working.

2) That the Chairperson of DTC writes to the Leader of Dover District Council urging the district council to declare an Ecological Emergency at the earliest opportunity.


#### **Declaration of Ecological Emergency**

There are an overwhelming series of scientific studies and evidence produced. I present below, a selection of statistics –

For the **Deal** National Grid 10-km square TR35 the **<u>British Trust for Ornithology</u>** "Doorstep Birds" project (2023, via the data collection app Bird Track and their Bird Atlas research) records that, since 1970 –

- 19 species of breeding bird species lost from the Deal area, including Tree Sparrow, Black Redstart and Whinchat.
- 24 species are recorded as declining including more familiar birds such as Swift, House Martin, Song Thrush, Mistle Thrush, Starling, House Sparrow, Greenfinch and Goldfinch.
- A few species are increasing, such as Collared Dove, Feral Pigeon, Lesser Black-backed Gull and Magpie.

The **<u>British Trust for Ornithology</u>** has conducted counts of the population of our birds for many years and here are some of the graphs for a range of Deal's urban bird species:




Starling (Sternus vulgaris)

Common Swift (Apus apus)

The BTO Breeding Bird survey also records other wildlife levels and has found that Rabbits have declined by 67% and the Red Fox by 48%. As a contrast, the alien Eastern Gray Squirrel, to give its proper name, has increased by 30%.

#### How wildlife has declined, 1970-2016



The "Living Planet Report" by the  $\underline{\textbf{BBC}}$  records the state of our wildlife thus –

### The State of the World's Plants and Fungi 2020 report from Royal Botanic Gardens Kew

estimated that 39.4% of plants are now threatened with extinction. This is a jump from one in five

plants thought to be at risk in Kew's 2016 report. The COVID-19 pandemic has highlighted the relationship between people and nature.

The <u>World Wild Fund for Nature</u> reports that since 1970, around the world we've lost: 60% of wild invertebrates and up to 76% of insects.

The <u>Mammal Society</u>, with the <u>University of Sussex</u>, has found that – There has been alarming declines in some mammal species in the UK - five of seven species of small mammals assessed were found to have declined by an average of 1.2-2.8% *each year* between 1970 and 2016. Some species, previously thought not to be at risk are now of high concern requiring immediate conservation action.

The <u>Royal Society for the Protection of Birds</u> notes the following – Nature conservation improves the quality of people's lives. Nature has the power to boost our health, happiness and wellbeing. Protecting wildlife benefits society: it provides the resources to sustain and enhance our health; it offers educational opportunities; it contributes to the regeneration of sustainable communities and it supports and generates economic activity. To be sustainable, communities need green infrastructure – where it is not available, we need to create wildlife-rich green space. **UK Government's Environmental Improvement Plan 2023** notes that Local Nature Recovery Strategies (LNRS) are a key component of the Environment Act 2021. The aim of a LNRS is to set out how to deliver nature recovery across England. The Guidance and Regulations for LNRS was published by Defra on 23 March 2023. Local nature recovery strategy statutory guidance (publishing.service.gov.uk)

The <u>Wildlife Trusts UK</u> provides the following information about the decline in our insect populations – In the UK, our insect populations have suffered drastic declines, which are set to have far-reaching consequences for both wildlife and people. With a third of our food crops pollinated by insects, and as many as 87% of our plants pollinated by animals (and in the majority by insects) there is a lot to lose. Much of our wildlife, be it birds, bats, reptiles, amphibians, small mammals or fish, rely on insects for food. Without them, we risk the collapse of our natural world. A report, *Insect Declines and Why They Matter*, published in November 2019 by an alliance of Wildlife Trusts in the south-west, brought together evidence that showed the loss of 50% or more of our insects since 1970, and the shocking reality that 41% of the Earth's remaining five million insect species are now 'threatened with extinction'.

Research by the Marine Conservation Society UK has found that 49% of marine organisms have declined with over-fishing, pollution and climate change the principal causes. Walmer beach zone and the offshore environment are suffering at this moment. Many local groups have experience of this.

**Butterfly Conservation** has found that – In the UK, long-term trends show that 80% of butterfly species have decreased in abundance or distribution, or both since the 1970s. On average, UK butterflies have lost 6% of their total abundance at monitored sites and 42% of their distribution over the period 1976-2019.


Our own Kent Wildlife Trust has found that we have lost 60% of our insects over the last 20years.

#### **Recommendations:**

1) The Environment Committee recommends that Full Council agrees to the Environment Committee implementing actions on local nature protection and recovery, including community engagement and partnership working.

2) The Environment Committee recommends that the Chairperson of DTC writes to the Leader of Dover District Council urging the district council to declare an ecological emergency.

At September's Full Council, Members RESOLVED: To go ahead with Warm Welcome 23/24 as recommended and to issue the venue payments in two halves, half up front and the second payment when the monitoring reports have been received. To request that further information is received from United Families and Deal Foodbank on how they would use funding to help residents in urgent need and to keep warm is brought to the next meeting of full council before a decision is taken on this funding.

Following the council's decision, the Communications Officer has contacted Deal Foodbank and United Families to request how both organisations would use the funding. They have advised:

Deal Foodbank:

- £500 would be set aside to purchase slow cookers (£29.99) from a local retailer to be given to people in need in Deal to reduce the cost of cooking food.
- £500 would be used as a crisis fund to provide direct help to people struggling to pay energy bills or feed themselves or their families.

United Families:

- £500 would be set aside to purchase air fryers (£39.99) from a local retailer to be given to people in need in Deal to reduce the cost of cooking food.
- £500 would be used as a crisis fund to provide direct help to people struggling to pay energy bills or feed themselves or their families.

Both Deal Foodbank and United Families have confirmed they have stringent measures in place to ensure those seeking financial support are genuine. Both have the expertise and infrastructure to be able to directly support people and families in Deal unable to afford food and energy bills.

A condition of the funding is that the money is ring-fenced and only used to provide support to Deal families and residents this winter. Monitoring information will be recorded, and a full report will be submitted at the end of Deal Warm Welcome in April 2024.

Deal Warm Welcome was established in October 2022 by Deal Town Council to support residents who may struggle to manage their budget through the winter. Venues were established across the town, providing a food offer, offering hot and cold drinks, a warm, friendly environment, support and signposting to additional services. Creating direct funding this winter allows us to develop the Deal Warm Welcome and reach more people in need in the town.

In November 2022, the Finance & General Purposes Committee resolved to add a budget line for Warm Spaces with a budget of £10,000 for 2023/24. Including £6,132 for the six venues and £400 for marketing costs, this would bring the projected total for this year's Deal Warm Welcome to £8,532.

#### **Recommendations:**

To approve the development of the Deal Warm Welcome project to include Direct Funding and grant:

- £1,000 from the Warm Spaces budget to Deal Foodbank
- £1,000 from the Warm Spaces budget to United Families

#### 1. Purpose of Document

On 31 January 2023 members resolved to sign the pledge of membership to become part of the City of Sanctuary initiative.

**RESOLVED** that the following objectives be approved and submitted as the shared vision for the City of Sanctuary accreditation application:

1	Deal Town Council is committed to welcoming asylum seekers and refugees to Deal.
2	Deal Town Council recognises the potential of refugees and their contribution to our town
3	Deal Town Council adopts a comprehensive, co-ordinated and forward-looking approach to the needs and welfare of people moving into the town and supports building community cohesion between new and existing communities
4	Deal Town Council, in conjunction with DARA, will work to implement the City of Sanctuary pledges through its action and policies together with its partners in the statutory and voluntary sectors
5	Signing the membership pledge means Deal Town Council will develop a "Town of Sanctuary" strategy and ensure the needs of refugees and asylum seekers are considered in its policies and working practices.

The Strategy & Action Plan has been prepared in collaboration with Kent Refugee Action Network, The Samphire Project and DARA and with an open minded view to work with all stakeholders for the benefit of people seeking sanctuary.

The Strategy & Action Plan sets out what Deal Town Council will do to make Deal a welcoming town for people seeking sanctuary.

#### 2. Background

City of Sanctuary is a mainstream, grassroots movement. It works by creating opportunities for relationships between local people and those seeking sanctuary, and by offering a positive vision of a culture of hospitality and practical assistance for those in need of safety.

Deal Town of Sanctuary as part of this organisation, will be made up of different people and organisations who work in different ways to make the town a place of welcome and safety for people seeking sanctuary from violence, war, and persecution. In support of this work, it builds on practical experience of welcoming strangers to Deal for many years.

Deal is aiming to apply for City (Town) of Sanctuary status in autumn 2023.

Deal Town Council has signed up to the Local Authorities City of Sanctuary Networks Group.

#### 3. Principles

Our aims and priorities are underpinned by a *Human Rights* approach with an emphasis on self-help. Deal Town Council will seek to act in accordance with City of Sanctuary principles to demonstrate good practice in working with people seeking sanctuary and to encourage others within the town to offer the same good practice.

Deal Town Council will work in partnership with the voluntary sector and with asylum seeking and refugee communities, and with all organisations who support City of Sanctuary principles and who are committed to welcome, inclusion and equality.

We recognise the influence which Deal Town Council can have on public perception and understanding of asylum seekers and refugees, and their reasons for seeking sanctuary in Deal, if we use positive and accurate language about people seeking sanctuary in all media, policy statements and publicity materials.

#### 5. Consultation

The strategy aims to improve consultation with refugees and asylum seekers on local town issues. The strategy also aims to improve consultation and shared working with those involved in providing services for refugees and asylum seekers.

**DARA** (Deal Area Refugee Aid) was formed in 2021 as a humanitarian response to the emergency evacuation from Afghanistan and with the increase in people arriving after hazardous journeys across the Channel. The group's main activity developed with active fundraising with increasing support from the public in the town.

**Samphire** started life as the Dover Detainee Visitor Group back in 2002. It came into being as a result of concerns felt by a number of local residents about the plight of the people detained at the newly established Dover Immigration Removal Centre – a Prison Service operated facility for detaining up to 400 migrants on the site of a disused borstal on Dover's Western Heights. Their mission is to improve the lives of people released from immigration detention and experiencing destitution in the UK, and to support the development of well-informed, cohesive, and diverse communities in the Dover area and beyond.

**KRAN** was established in 2003 to support refugees and asylum seekers (RAS) in Kent. Over the past years, it has grown to develop several projects in response to the needs of young RAS. One of our first projects, which continues today, is the Mentoring partnership project matching local volunteers in the community with young people.

#### 6. A Co-Ordinated Community Response

The Town of Sanctuary accreditation will raise the profile the work being undertaken for the benefit of refugees and asylum seekers and how the community can support this work, seeking to encourage a coordinated community response to bring people together to identify who does what and when to enable a service user or issue onto the relevant organisation.

It also seeks to start and share the evidence of good practice that is already taking place by other local authorities and voluntary organisations to enable awareness of this, how the community in general can assist in these operations.

Some people seeking sanctuary need generic services to help them rebuild their lives and flourish and others have specialist care or health needs and need to use specialist services. Generic services need to be supported to ensure they have sufficient understanding to include people seeking sanctuary in everything they do, but also understand when to refer to specialist support services. It is noted that some specialised knowledge is needed to work with people seeking sanctuary, especially when offering advice, legal advice, and advocacy.

As the Strategy & Action Plan is implemented a more coordinated and transparent Community Response will develop to ensure better outcomes for the refugee or asylum seeker. In addition, it will aim to ensure that everyone, who wants to do more to support refugees and asylum seekers, is able to contribute.

Resettlement programmes in particular, where people seeking sanctuary are brought into the UK and are given full citizenship rights from arrival, provide opportunities for active citizens and volunteers to volunteer and contribute to improving the lives of resettled families. Any volunteering must comply with safeguarding best practice and there should be supervision of volunteers working with resettled families.

#### 7. Conclusion

Deal Town Council will work closely with DARA, KRAN and Samphire and the local community to ensure it provides a safe, welcoming and inclusive environment for people seeking sanctuary within the town of Deal.

In 2021 the Phlebotomy Unit at Deal Victoria Hospital was proposed for closure. Members agreed that this would be to the detriment of the people of Deal and wrote to the Clinical Commissioning Group to urge them to reverse this decision. This was unsuccessful and the unit closed in 2021.

However, as members will be aware the provision for blood tests is now being reinstated temporarily at Deal Victoria Hospital after this service was removed two years ago. NHS Kent and Medway have advised this will be commissioned for 12 months to establish service demand and determine next steps.

The local MP Natalie Elphicke presented a petition to parliament which called for this facility to be returned and this was signed by more than 3,000 people.

Cllr Bano in his role as the Council's outside body representative on the Deal Speaking Up Group has submitted the following recommendation from them to full council for consideration.

#### Recommendation from Deal Speaking Up Group:

Phlebotomy Service at Deal Hospital: There is some indication that this service will be available again but with limited eligibility for the service. For this reason, we request that the Chairperson of the Council writes to the Commissioners to seek clarification of the current proposals.

Thank you for your email correspondence of 6 September on behalf of Cllr Oliver Richardson, Chairperson of Deal Town Council, Town Hall, High Street, Deal, CT14 6TR, about the removal of murals inside the Kent Intake Unit (KIU) in Dover.

We take the welfare of minors incredibly seriously and that is why we have said it is not compassionate to allow people - including vulnerable children - to be risking their lives any longer on perilous small boat crossings. Our comprehensive plan to stop the boats is focused on saving lives by removing the incentive to cross the Channel in unseaworthy vessels.

Where minors do come here through these dangerous means we take our safeguarding responsibilities and their welfare extremely seriously. We process arrivals in reception centres as quickly as possible and place children in appropriate, safe and secure accommodation with local authorities as quickly as possible.

Very few under-13s pass through the KIU, and these children are prioritized to be moved to Kent County Council care at the earliest opportunity. The overwhelming majority of unaccompanied children who passed through the location last year were teenagers. It was not felt that the murals were age appropriate.

The KIU is fully equipped to meet the needs of unaccompanied children. His Majesty's Inspectorate of Prison's most recent report on the KIU found that good support was provided to the children by the on-site team of social workers, and that the individuals in the unit were happy with the treatment they received there.

The National Transfer Scheme (NTS) ensures these minors are moved to a different local authority as quickly as possible. To advance this work, since 1 April 2023 the Home Office launched a new incentivised funding programme, with £6000 of funding available for each unaccompanied child transferred to a local authority within five working days.

The facility in question features practical measures in line with our welfare and safeguarding responsibilities which we take very seriously – namely larger interview rooms, an outside space, prayer rooms, a larger reception area and improved security measures.

There was no financial cost to the taxpayer to paint over the murals in the Kent Intake Unit.
