Declarations of Interest

Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensations, withdraw from the meeting.

Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer, etc would both probably constitute either an OSI or in some cases a DPI.

Subject: DDC response to Freedom of Information request

At the Environment Committee meeting held on 28th August 2024, I advised members that as Chairperson of the Environment Committee I had submitted a Freedom of Information request to Dover District Council regarding the Southern Water Funding for the Deal Bathing Water Enhancement Programme, the questions asked are as follows:

- For a breakdown of how the £3.9 million allocated to improving water quality at Deal Castle was spent.
- How has the Council monitored delivery of the project.
- Whether there are any plans in development to install further water quality testing stations between Deal Castle and Sandwich Bay.

Dover District Council have responded with the following:

I am writing in respect of your enquiry for information held by this Authority received on 19 August 2024 and to confirm that we have completed the search for the information that you requested. The information you have sought is set out below.

1. How the Council has worked with Southern Water to coordinate the spending of this money.

Meetings held at DDC offices and SWA location Worthing Sussex.

2. Has there been any formal meetings to monitor progress and outcomes?

Yes, stakeholder meetings with SWA representatives were held between November 2018 and Summer 2019. Recent meeting with SWA and Environmental Protection representatives on 7 August 2024.

3. If available a breakdown of how the £3.9 million was spent, or how it was intended to be spent when the Council was first made aware of this project.

It is our understanding that the £3.9 million allocated for Deal Castle Beach was not solely for Dover District Council. The funding was part of Southern Water's long-term aim to work with local authorities, the Environment Agency, farmers and landowners to bring up the quality of bathing water. Please see attached DDC costing schedule from Southern Water grant.

4. Are there plans to install any further water testing stations along the coast between Sandwich Bay and Deal Castle?

Sampling positions for Designated Bathing Beaches are located under the EU Bathing Water Directive 2006/07. There are no plans to identify additional sampling locations.

If you have any queries about this email, please contact me. If you are unhappy with the response, you can request an internal review of our decision.

If you are not content with the outcome of the internal review, you may apply directly to the Information Commissioner for a decision. Generally, the ICO cannot make a decision unless you have exhausted the procedures provided by the Council. The Information Commissioner can be contacted at https://ico.org.uk/global/contact-us/.

At the August Environment Committee meeting, the Deal Bathing Water Quality item was discussed on the agenda and following a lengthy discussion, Members RESOLVED: For Cllr P Findley to explore with the Climate Change Officer a future Project Plan and awareness strategy for an Ocean Recovery Declaration and bring this back to Committee.

I arranged a meeting with the Climate Change Officer which also included the Town Clerk and Committee Clerk, to discuss how I could feasibly approach this project and produce a strategy for the benefit of our coastal town. (See attached project plan template).

Recommendation: The Environment Committee agrees to support this project which is in line with Deal Town Council's Carbon Reduction strategy and to recommend this project plan to the October Full Council meeting for approval.

We will explore methods of developing strategies to support our coastline and seas at Deal and beyond through meetings, discussion and planning. This will result in the following –

- 1. Producing a set of realistic actions that can be promoted by the Council
- 2. Meeting with local stakeholders to gather data to inform decisions
- 3. Meeting with local stakeholders to ascertain what is already being carried out
- 4. Considering how efforts already being made can be supported
- 5. Focussing on the problem of litter, collecting data, recording what has already been achieved by local organisations and exploring how we might support this
- 6. Developing a strategy for the reduction of plastic use
- 7. Collecting relevant data from national and regional sources to establish the rate of chemical and biological pollution offshore
- 8. Researching strategies developed by other, similar councils

- 9. Consider how our local coastal and maritime wildlife might be enhanced
- 10. Ascertaining the concerns of local people and community groups
- 11. Measure and publicise our results

PROJECT PERIOD (How long will the project run? When do you want it to start?)

EVIDENCE OF NEED: (Why is it needed? How do you know?)

- 1. Several local groups have presented their concerns about the state of Deals' beaches and the sea. At August's Environment Committee it was noted that water quality has gone from 'excellent' in 2019 to 'poor' in 2023 and an FOI submitted to DDC asking how the £3.9 million allocated for coastal improvements was spent.
- 2. "A healthy Ocean is essential for our health, wellbeing and prosperity, but the evidence is clear that our Ocean is in crisis. Local authorities cannot solve the Ocean crisis alone, but they can and must play their part. I am thrilled to see 25 Councils now taking meaningful Ocean action as a result of our Motion for the Ocean and look forward to many more to come. The tide is turning!" Emily Cunningham, Ocean Conservation Expert and Co-Founder of the Motion for the Ocean
- 3. Marine Conservation Society says "Every year an estimated 11 million tonnes of plastics enter our ocean. 29 million metric tonnes of plastic is expected to enter the ocean every year by 2040 It's estimated that 1.5 million tonnes of microplastics enter the ocean every year. Between 30-40% of UK fish stocks are overfished. Only 1% of fishing trips are independently monitored. 11 of 15 indicators of ocean health are being failed by the UK. 81% of people said they felt healthier when they were by the coast and sea.
- 4. ORCA "The UK Government is failing to protect whales and dolphins, concludes a House of Commons select committee report in 2023. NGOs submitted evidence and were witnesses in the inquiry and continue to urge the UK Government to make positive changes to protect marine mammals in UK waters"
- 5. National Geographic "Marine pollution is a combination of chemicals and trash, most of which comes from land sources and is washed or blown into the ocean. This pollution results in damage to the environment, to the health of all organisms, and to economic structures worldwide."
- 6. **KentLive –** Map shows the Kent bathing spots where it's too polluted to bathe.
- 7. Environment Agency Their own figures Check the quality of beach and bathing water in England GOV.UK (www.gov.uk) This measures what and where they choose to measure
- 8. Surfers Against Sewage A rich, diverse ocean is a healthy ocean. And a healthy ocean is a healthy planet. The UK has some of the most varied sea life in the world, but human actions mean this is just a shadow of what it was. We've lost many of the biodiversity-rich habitats that once graced our coastlines. For example, in the last 200 years we have lost 80% of salt marshes, which are ten times more effective at capturing carbon than terrestrial ecosystems. Seabird numbers in the UK have plummeted by up to 70% in 25 years and 50% of UK sharks and rays are in a Threatened or Near Threatened category on the International Union for Conservation of Nature's (IUCN) Red List of Threatened Species. Human activity. Overfishing, ocean pollution, overexploitation of certain species, the introduction of invasive species, and ocean acidification and warming, have led to the destruction of marine ecosystems. Deep-sea mining and industrial fishing practices have destroyed many seabed ecosystems, resulting in the bycatch of thousands of dolphins, whales, seals and seabirds, depleting fish stocks and sending shockwaves down oceanic food webs.

Subject: Safety of Lithium ion batteries Bill

Deal Town Council received communication at the end of May 2024 from a parliamentary adviser to Electrical Safety First which is a UK charity dedicated to reducing the deaths and injuries caused by electricity, he was a researcher for Lord Foster of Bath a member of the House of Lords, who has been campaigning on the issue to improve the safety of Lithium ion batteries used on e-bikes and e-scooters.

This item was placed on the June Environment agenda and Members RESOLVED: To support the Safety of Electric-Powered Micromobility Vehicles and Lithium Batteries Bill and for the Chairperson in liaison with the Committee Clerk to write to Lord Foster of Bath confirming this and requesting feedback.

Following the above resolution, the Chairperson of the Environment Committee wrote offering Deal Town Council's support for this Bill. We have since received the following information from the Parliamentary Adviser for this Bill stating:

<u>Lithium-Ion Batteries Campaign: Update 1st October</u>

The Private Members Ballot for Bills in the House of Commons took place on Thursday 5th September as previous supporters will know. I had said that I would be in touch in regards to successful MPs, but two days before the Ballot, the Government published its own Product Safety and Metrology Bill which covers many of the issues in our Bill and so no MPs who were successful in the Ballot would adopt our Bill, so I didn't urge you to lobby your MPs. I know some of you had done that already – and that was not wasted effort because the Government's own Bill was not due to be introduced for some months and it was the profile of the issue that sped it up.

"Lithium-ion Battery Safety Bill: This was introduced in the House of Lords by Lord Redesdale, and it had a successful reading on 6th September. This Bill covers all the issues in our Bill: Clause 4 deals with independent certification; Clause 5 with disposal; Clause 6 with chargers and conversion kits.

Action Requested: The government minister in the House of Lords in charge of this Bill is Baroness Jones of Whitchurch. It is vitally important therefore that she is made aware of the sense of feeling in support of Clauses, 4, 5 and 6 of the Bill.

Therefore, it would be great if you could write to the Minister, Baroness Jones, at jonesmag@parliament.uk urging her to either support Lord Redesdale's Bill or to slot it into the Government's own Bill."

Recommendation: The Chairperson of the Environment Committee in liaison with the Committee Clerk writes to Baroness Jones the Government Minister in charge of this Bill and expresses Deal Town Council's support to the new clauses 4,5,& 6 of the Bill.

Deal pledged almost 220 kilos of CO2e emission savings this summer Pollution equivalent to a car journey from Deal to Durham and back again has been saved thanks to Best Foot Forward pledges this summer.

More than 750 miles were collectively pledged by local residents who signed up to walk or cycle a short journey instead of driving.

The average petrol car produces the equivalent of 290g of CO2e every mile, so if you swapped a one-mile round trip by car once a week, in a month you've reduced your emissions by more than a kilogram*

Deal Town Council's Best Foot Forward campaign collectively pledged to remove 219.82 kilos (758 miles) of CO2e emissions.

Mayor of Deal, Cllr Oliver Richardson said: "I'd like to say a great big thank you to everyone who signed up to Best Foot Forward this year. By making a small change and walking or cycling instead, not only do we cut down on local pollution, we are getting active too. The campaign shows that on our own we can and do make a difference, but collectively, the impact can be huge!"
