Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration, they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensation, withdraw from the meeting.

Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of or vote taken on the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc. OR an application made by a Member, relative, close associate, employer, etc. would both probably constitute either an OSI or in some cases a DPI.

DDC have recently advised that the Tax Base figure for Deal in 2026/27 will drop from 7,432.26 to 7,425.78

Based upon the recommended draft budget for 2026/27 and the Tax Base figure for 2026/27, this will mean an increase in the 'Band D' figure of 3.55% from £79.36 to £82.18

As Full Council will be aware, Deal Town Council has an ongoing Highways Improvement Project Plan which was agreed in March 2022. The plan is to focus on benefiting vulnerable road users, accessibility, and research into small necessary improvements to the highway in Deal's three wards.

The KCC EHI Team have advised DTC that they will only be able to part-fund three drop kerbs at the following locations from our 3rd Highways Improvement Plan:

- Darracott Close (London Road)
- Cowper Road (London Road)
- Golf Road (North end)

The total cost for the installation of the three drop kerbs £6,932.29, of which KCC would be prepared to fund 13%, leaving Deal Town Council to fund the remaining £6,000.

Following the November T&I Committee meeting, Members RESOLVED: *To recommend to Full Council that the remaining £6,000 for the cost to install three drop kerbs from Deal Town Council 3rd HIP application be funded from the DTC Project Fund.*

KCC Update – DTC HIP

The Committee Clerk and Deputy Town Clerk have had numerous meetings throughout the year with KCC East Highway Improvement Team, they advised DTC Officers in December 2025 that they will be fully funding 4 drop kerbs from our 2nd HIP application at the following locations: St Richards Road (near St Mary's School and Doctors surgery), Mill Road (Manor Road end), Mill Road (outside the Co-op Supermarket) and Prince of Wales Terrace (Seafront by Sondes Road). Re: **Report on FOND (Friends of North Deal) event 5th December 2025.**

On 5th December 2025 I attended a public event designed to address local concerns over speeding and other traffic issues in Deal. This took place in the Golf Road Community Centre and was attended by about ten people.

The lead speaker was Inspector Alan Watson, who is the Special Inspector for Speedwatch across Kent. There was a PowerPoint presentation.

Key points which came out of this are

1. Experience has shown that a 20mph limit in urban areas such as ours did not have a significant impact on speeding.
2. Speedwatch did make a difference when run at regular intervals.
3. Small local roads were rarely suitable for Speedwatch – it was used on roads with a 30mph limit where actual speeds might be above 35 mph.
4. The Speedwatch manager (Alan) would advise and the Police force would provide training and equipment if a Speedwatch team were to be put together for Deal.
5. Local resident, Pam, already a member of the Walmer Speedwatch team, recommended it to the audience.
6. If the residents identified key roads the Inspector would obtain information on actual speeds already measured and in police databases. This would inform the next steps.

The PowerPoint was followed by a discussion. Inspector Watson committed to passing on information from the police database about average speeds on key roads in the town.

The instigators of the meeting formed a small action group to take ideas forward into 2026.
